Hummingbird International, LLC. Scholarship Terms and Conditions

The \$3000 Logo Design Scholarship (hereon Scholarship) is provided by Hummingbird International, LLC, herein referred to as HB, (and its sister concerns), located at 668 Stony Hill Road, Suite 11, Yardley, PA 19067. The following terms and conditions apply when applicant is selected for Scholarship Award for financial aid (hereon Award).

Scholarship Eligibility

The Scholarship is open to rising college juniors and seniors for the semester duration 2017-18 who are currently enrolled in an accredited graphic design degree program in the United States. Students must be a minimum of 18 years old and have a GPA of 2.5 or higher. Students must have completed and submitted application in full by marked deadline*.

1. Scholarship Award Terms

- I) Once Scholarship awardee is chosen an Award Letter will be sent to the awardee. The awardee will be required to submit the Award Letter to their respective university financial aid and/or billing department.
- II) The Award will be made directly to the university and the Award will be applied based on the university policy and procedure. Generally, Awards will be split between the fall and spring semester, meaning half of the total scholarship award will be applied towards the fall semester and the second half towards the spring semester, (\$1500 respectively). The Award is an Outside Scholarship Award and may impact the amount of other scholarships awarded to the awardee.
- III) Additionally, Scholarship Award is for the sole purpose of education benefits and must be applied in full for that purpose. Any monies used for room and board may be considered taxable income and it is recommended that the awardee seek counsel of both the financial aid office and that of a professional accountant to fully understand the implications that an Outside Scholarship will have on preexisting scholarships and grants received.
- IV) As the Scholarship applicant, you agree to be bound by these terms and by the decisions made by HB, which are final and binding in all respects. HB holds the right

- to make any decisions regarding your disqualification if you violate these terms, tamper with the operation of the scholarship or engage in any conduct that is detrimental or unfair to HB, the scholarship or any other individual who has applied for the scholarship.

2. Scholarship Period: How to Enter, Awards and Odds

- III) Scholarship Award will be paid directly to the winner's educational institution on behalf of the scholarship winner. Scholarship notifications returned as undeliverable or scholarships otherwise not effectively claimed, by executing and submitting an Affidavit of Eligibility, and Release, within 10 calendar days after delivery of notification will be forfeited and awarded to an alternate winner.
